## **IMPORTANT NOTICE – 25<sup>th</sup> November, 2024**

### **1. Seat Availability:**

- Total Seats : **170 seats**
- Seats Reserved as per Right to Education Act : **42 seats**
- Seats Available For Present Admission Process : **128 seats**

### **Terms :**

- Amanora Citizens: Children whose parents own residential property in Amanora Park Town.
- Siblings: Brother/sister of students already admitted in Pawar Public School, Hadapsar. Cousins are not considered as siblings
- Notice for General Public** will be displayed on **13<sup>th</sup> December, 2024** only in case if seats are vacant after confirming admissions to Amanora Citizens and Siblings.
- Forms will be accepted and admission will be granted only to Amanora Citizens and Siblings.**

### **2. Eligibility Criteria:**

- Age : All children born between **1<sup>st</sup> July, 2021 to 31<sup>st</sup> December, 2022.**
- **NO Relaxation** will be considered in the date of birth
- **No dues of school fee of sibling**
- The school reserves the right to deny admission to candidates without assigning any reasons.
- All documents need to be submitted at the time of admission.

### **3. Admission Dates: Wednesday, 4<sup>th</sup> December, 2024 to Friday, 6<sup>th</sup> December, 2024** between 9:00 am to 12:00 noon. No parents will be permitted to enter the school premises post the above date and time.

### **4. Admission Process:**

#### **Admissions for NURSERY for Amanora Citizens and Siblings only**

- Seats will be first allotted to Amanora Citizens and to Direct Siblings of our existing students.
- **Admissions are available for 128 seats only, and will be granted strictly to Amanora Citizens and Siblings.**
- **Cousins and Families residing on Leave License / Tenants / holding commercial property in Amanora Park Town will not be considered for admission under the Direct admission category.**
- **Parents will only be able to submit the online admission form if all documents are provided, and the admission will be confirmed on the same day.**

## 5. List of Documents: (Mandatory at the time of confirmation of admission)

\* Hard copies should be submitted at the time of confirmation of admission.

- **Kindly carry all the original documents for verification. Name of the child on Birth Certificate is mandatory. List of Documents:**

- **The name on the child's birth certificate and the name on the Aadhar card of the student and parent has to be same. Any mismatch of name on either of the document will not be accepted and the admission will not be granted.**
- **Aadhar card and birth certificate of student is mandatory without which admission will not be granted. No time concession will be considered for submission of documents.**
- **In case of Birth certificate in languages other than English / Hindi / Marathi, please bring a notarized copy of the certificate translated in any languages mentioned above.**

## 6. Payment of Fees:

- All the required documents along with
  - Demand Draft for Caution Money Deposit (refundable): ₹ 70,000/- drawn in favour of 'Pawar Public School'.
  - Demand Draft for Infrastructure, First two installments and admission fees (non-refundable) : ₹ 64,515/- drawn in favour of 'Pawar Public School' and
  - A **form fee of ₹2000/-** is to be paid **online** during the submission of the admission form. Payment can be made through **Net Banking, Debit Card, or Credit Card.**
- Fee Schedule is displayed on the notice board. (Kindly refer page no. 4 for details)
- **Fees once paid are Non – refundable under any circumstances except for Caution Money Deposit.**

## **7. Allotment of batches:**

**Nursery section runs in two shifts**

**Shift-1: 7:50 am to 11:10 am**

**Shift-2: 11:20 am to 2:40 pm**

**The shifts will be allotted solely at the school's discretion. However, parents can mark their batch preference. Batches will be allotted on first come-first serve basis. Batches once allotted, **no request for change in shifts** will be entertained. Parents kindly note this before confirming your admission.**

## **8. Points to be noted:**

- i. Admission for Nursery for Academic year 2025-2026 will be confirmed on the dates mentioned in point 3.
- ii. Parents will need to carry a photocopy of all the documents notarized along with the original documents and fees as mentioned in point 6 and visit school during the date and time mentioned above. **The online form needs to be filled and submitted from the school and the admission too will be confirmed on the same day.**
- iii. **Amanora Citizens : Index II copy/letter of allotment etc. needs to be attested by the Amanora office Civic Centre and it is mandatory to be submitted for admission under Amanora Citizens Category.**
- iv. The detailed notice for commencement of school classes will be updated on the school website along with the division / batch details after 20<sup>th</sup> February, 2025.
- v. **Under any circumstances, the fees are always payable to school.**
- vi. **Fees once paid will not be refunded under any circumstances except the Caution money Deposit.**
- vii. Admission will be confirmed on submission of all documents along with fees. No relaxation will be granted for document submission. Aadhar card and Birth Certificate is mandatory for all at the time of admission.
- viii. No relaxation in age, admission date and time will be considered.
- ix. Medical form should be duly attested and signed by a Registered Medical Practitioner (MBBS/M.D.) and Parental Consent along with the Medical form should be duly signed by the parents. Both forms along with other documents need to be submitted at the time of admission.

- The School will not entertain any correspondence, discussion, telephonic or personal inquiries regarding the admission process.
- Any intervention or pressure in the normal admission process will lead to immediate disqualification of the applicant.

- Mode of Payment:** Fees at the time of admission will be accepted in form of DD only. in favour of "Pawar Public School". Thereafter the fees can be paid online through the school website using your wards login at [www.ppspune.com](http://www.ppspune.com) -ecampus
- PTA fees and School Diary:** ₹ 300/- to be paid annually using your wards login at [www.ppspune.com](http://www.ppspune.com) -ecampus in the month of **April, 2025**.

**3. Fee Payment Due Dates:**

1 <sup>st</sup> Installment	Before 10 <sup>th</sup> April
2 <sup>nd</sup> Installment	Before 10 <sup>th</sup> July
3 <sup>rd</sup> Installment	Before 10 <sup>th</sup> October
4 <sup>th</sup> Installment	Before 10 <sup>th</sup> January

- Late fee charges:** a fine of ₹ 500/- per month will be charged for fees received after the due date.
- Cheque Bounce:** A penalty of ₹ 500/- will be charged and payable by parents for cheques dishonoured/bounced/returned by the bank for any reason.
- The annual fees are revised every two years as per Government resolutions. The current fees are applicable for academic year 2024-2025 and 2025-2026.
